Reference: Sanctions against athletes and IDSF-licensed Adjudicators competing and adjudicating in competitions not registered by IDSF Member Bodies

Dear Members,

As you all know, the 2008 Dutch Open held in Assen, The Netherlands, on November 13 – 16, 2008 and the so-called 2008 World Amateur Ballroom and Latin Championship held in Paris on December 5 – 7, 2008 were not registered by the respective IDSF Member Bodies.

Prior to these two events, the IDSF General Secretary and IDSF Sports Director published clear notices on the IDSF website from April 16, 2008 about them. They also contacted all IDSF Member Bodies by e-mail on two separate occasions warning that athletes should not participate in these two events.

The email explained that the IDSF Presidium may take action against any athlete, adjudicator or other official, person or body associated with IDSF, or an IDSF Member who competes, adjudicates or otherwise participates in those competitions/events in any way, without any further notice, in accordance with the applicable IDSF Rules and Regulations.

It was also explained in the notices that in the event of any sanctions being imposed by IDSF upon any competing athlete, adjudicator or other official, person or body associated with IDSF, or an IDSF Member, IDSF will not be liable for and will refuse to pay any expenses or other costs which may arise due to the action taken against an athlete or adjudicator whether in relation to these specific events or in relation to any further IDSF events.



Presidiums decisions

During the last IDSF Presidium Meeting held in Barcelona, on January 17 & 18, 2009, the IDSF Presidium unanimously resolved:

a) to confirm the decisions of the Sports Director and the General Secretary to notify the respective IDSF Member Bodies that the following athletes were not permitted to compete in the 2008 Tattersall's IDSF World Latin Championship, held on December 14, 2008, in Melbourne, AUSTRALIA:

- Troels Bager / Ina Jeliaskova DEN
- Lenny Gouweroh / Laura Zrajkovicova, NED
- Eldar Djafarov / Anna Sazhina, AZE

b) that all IDSF athletes competing in the unregistered Assen events are further sanctioned with a suspension from all IDSF registered events for a period of six month commencing from November 16, 2008 – May 16, 2009.

c) that all IDSF athletes competing in the unregistered Paris events are further sanctioned with a suspension from all IDSF registered events for a period of six months commencing from December 7, 2008 – June 7, 2009.

d) that all IDSF athletes competing in the unregistered Assen and in Paris events are further sanctioned with a suspension from all IDSF registered events for a period of nine month commencing from December 7, 2008 – September 7, 2009.

e) that any IDSF athletes competing in unregistered Assen and/or Paris events will lose their ranking points collected as a couple with immediate effect and will be deleted from the IDSF World Ranking List with immediate effect.

f) that all IDSF licensed Adjudicators who adjudicated in Amateur events in Assen will be sanctioned with a suspension of their IDSF Licenses for a period of six months commencing from November 16, 2008 to May 16, 2009.

g) that all IDSF licensed Adjudicators who adjudicated in Amateur events in Paris will be sanctioned with a suspension of their IDSF Licenses for a period of six months commencing from December 7, 2008 to June 7, 2009.



- h) that the General Secretary is instructed to send a copy of this resolution and a list of the sanctioned Athletes and IDSF licensed Adjudicators to all IDSF Member Bodies (current list attached to the Presidium Minutes).

Due to the fact that these Athletes and Adjudicators are sanctioned by the IDSF, we kindly inform you that we also attached to this e-mail a list of all sanctioned Athletes and Adjudicators.

Please be so kind and check this list during this period of time, in order to be sure that none of them enter in any IDSF Competition organized in your country.
